Ten (10) Year Manufacturer's Limited Warranty

Your TEX-COTE® REFLECT-TEC® Heat-Reflective roof coating system is warranted for a period of ten (10) years from the date of application against chipping, flaking, or peeling from the surface to which it is applied. This warranty takes effect on the date of application of the product to your home. The Product is also warranted for a period of ten (10) years not to fade beyond ten (10) Delta E CIE units from the original color at the time of application. This warranty is effective only if the Product is applied over specified tile or metal roofing surfaces. If the product fails as described above, we will replace the product.

THIS WARRANTY DOES NOT COVER WATERPROOFING OR DAMAGE RESULTING FROM SETTLING OF THE BUILDING, MAJOR BUILDING MOVEMENT, CRACKING, ROOF LEAKS, ACTS OF GOD (e.g., WINDSTORMS, HAIL, FLOOD, HURRICANE, TORNADO, EARTHQUAKE), OR MECHANICAL OR EXTERNAL PHYSICAL CAUSES. **This warranty only covers products applied to a single-family residence, duplex, or triplex applied in accordance with our specifications. Non-covered structures include new construction, apartments, condominiums, multi-family dwellings (other than duplexes or triplexes), and commercial use.** This warranty also does not cover the portions of the product applied to fascia boards, entry and exit doors, handrails, trim and/or any movable surfaces. This warranty will be effective only if the product has been applied in accordance with our specifications and does not cover failures of the product caused by improper preparation of the surface, including but not limited to, failure to replace all broken tiles, spot-priming corroded or rusted areas with TEX-COTE® recommended anti-corrosive primer and/ or replace excessively corroded metal surfaces.

This warranty is transferable one (1) time, if transferred to a purchaser of your home within five (5) years after the Date of Application of the product and is otherwise extended only to the original purchaser of the product. Written notice of the transfer of this warranty must be given to us within thirty (30) days of the sale of your home.

For breach of warranty as a result of a defect in product, product replacement is our only responsibility and your only remedy. Tex-Cote LLC shall have no responsibility to apply the replacement product or to pay for or contribute to the cost of labor for such application.

There are no other express or implied warranties. The terms of this warranty are not subject to modification. The sales representative and/or contractor is not an agent or employee of Tex-Cote LLC and any additional promises or guarantee made by the sales representative and/or contractor SHALL NOT become part of this limited warranty.
